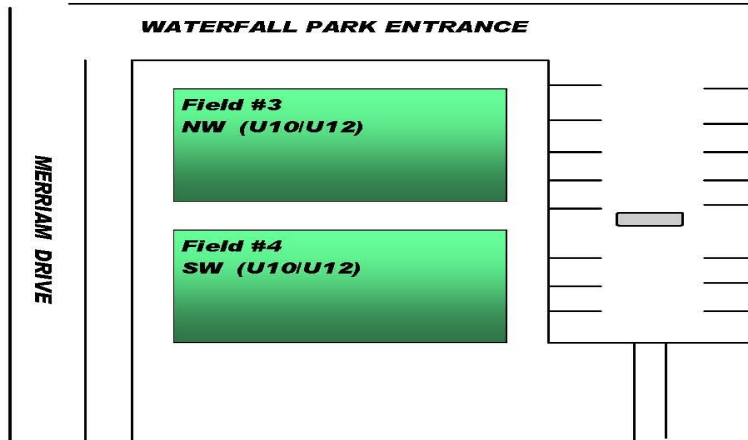
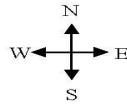

- Reservations must be made by persons 18 years of age or older who will sign permit assuming responsibility of the group.
- Practice times must be requested at least 7 days in advance.
- Reservations for fields available one year in advance.
- All rental dates must be paid for "in full" at time of reservation.
- Goals are provided. Practice fields are unlined. **DO NOT MOVE GOALS.**
- Rentals cancelled by the City of Merriam due to bad weather /field conditions may be rescheduled. The rental applicant must request cancellation of event in writing. If the request is received at least 31 days prior to rental date the rental fee, less a \$10 processing fee, will be returned.
- Failure to abide by facility rules or permit conditions may result in cancellation of reservation without refund.
- The U10/U12 field is 50 yards by 40 yards.
- Contact 913-322-5550 to report problems/concerns.

LIABILITY RELEASE: I, as an outside entity representing minor participants as well as adults, agree to release the City of Merriam, its officers, employees and volunteers, from all liability for accidents, injuries, loss of and/or damage to my/our people or property that may arise out of my/our participation in/and our presence at the above activity(s). I/we understand the risks and possible dangers of participating in these activity(s). Also, I/we authorize the Merriam Parks and Recreation Department to use at its discretion any photograph(s) (black/white or color) taken of the participant while participating in the program and waive any and all claims that the participant or the undersigned or their heirs, executors, administrators, or assigns may have or claim to have resulting from such photograph(s) or reproductions thereof. I have entered into this agreement of my own free will.

The undersigned agrees that this permit is issued with the express understanding that it can be suspended or revoked by the City if the permittee engages in misconduct or fails to clean and police the area adjacent to the facility that they are reserving. Failure to leave the area clean will result in discontinuation of the use of the facility. I have read, understand and agree to abide by the policies and fees for the type of facility I am applying to rent and I will be present at the facility during its use. I further realize the ramifications of failure to abide by the policies set forth in this document. I understand and that submittal of this form does not guarantee approval of my application.
